### DISPLAY ADVERTISING

The Village Council requires visually attractive ads in good taste, in a PDF or JPEG format. All ads are subject to approval by publisher. Advertising is not accepted for the back page, the calendar page, or the front page. Local advertising is encouraged, but priority for space is given to Village programs.

A signed contract and prepayment are required for all ads. Payment is by cash, credit card, or check made out to Friendship Heights Village. **The deadline is the fifth day of the month prior to the desired issue.** All display ads must be submitted in the correct size. Rates listed are per insertion. Multi-insertion contracts can be paid by pre-authorized credit card on a monthly basis at an additional charge of 5 percent. All multi-insertion rates are for consecutive months. In the event of non-payment, ad will be cancelled and the advertiser is responsible for paying the full amount of the contract. All ads must include the company name and the month of publication in the file name.

The content of multi-insertion ads may be changed, but the new ad must be submitted no later than the fifth of the month prior to publication. In the event a new ad is not submitted by the deadline, the previous month's ad will run.

Payment by check or credit card and the proposed advertisement must be submitted with this contract by the fifth of the month prior to the desired issue. The Friendship Heights Village Council cannot extend credit. Payments for multi-insertion advertisements may be made monthly (by pre-authorized credit card charge only) at an additional charge of 5%. Failure to pay for an agreed-to insertion in advance of publication (before the published deadline date for each issue) will result in non-publication and the advertiser will be billed for the balance due at the higher rate applicable to the number of insertions actually published. The content of multi-insertion ads may be changed, but the new ad must be submitted no later than the fifth of the month prior to publication. In the event a new ad is not submitted by the deadline, the previous month's ad will be published.
