Mail-in ballot applications have been delivered to each building and can be downloaded from the Village website. To allow time for processing and mailing, applications must be received by postal mail or email by April 26th. Instructions are on the ballot application. Ballots may be returned by postal mail or taken to the drop box at the Village Center. In person Voting will take place at the Village Center from 7 am until 8 pm on Monday, May 10th. A limited the number of voters will be allowed in the polling place at one time. If you received a mail-in ballot, you must vote that ballot. You may bring your ballot to the drop box before, or during, Election Day.

Eight candidates are running for seven seats. Each candidate was asked to write a statement describing why they are running for this office and what makes them qualified to serve. The statement was limited 1000 characters (not including spaces.) The League does not make any edits or corrections. The text is what was submitted.
